Art. 1 - The duration of the agreement will be annual. It shall not be tacitly renewable. In any case, the adoption agreement shall not entail for the "I LOCHI" business network the transfer of any property right on the adopted plant. If the initiative and the products have been satisfactory, the adopter must express the will to renew the contract by charging a subsequent adoption fee;

Art. 2 - Upon request, the adopter will be informed by e-mail about all the cultivation operations carried out on the adopted plant and on the harvest time, which takes place in each odd-numbered year;

Art. 3 - A plate with the name of the adopter and the duration of adoption will be affixed to the adopted plant;

Art. 4 - the "I LOCHI" business network offers the adopter the opportunity to visit the adopted pistachio plant on the basis of a 15 days notice period. The adopter is allowed to be present at the harvest (which takes place in each odd-numbered year) on the basis of one-month notice period;

Art. 5 - This agreement shall be valid only in Italy; in case of international adoptions, please, request information about the shipping charges to the following e-mail: [info@ilochi.it](mailto:info@ilochi.it)

Art.6 - The pistachio fruits and pistachio based products (according to the chosen option) will be despatched within three months of being harvested during odd years. If requested by the adopter, products will be sent also in even years.

Art. 7 - The adopter declares to choose the following option (please,tick with a cross):

Option A: In exchange for € 100.00 per plant, paid after the signing of the agreement in terms of purchase of future goods (chap. I art. 1472 of the Civil Code), the adopter will receive at home:

N° 4 bags (250 g. each) of certified "Pistacchio Verde di Bronte DOP" pistachio in shell;

N° 2 bags (250 g. each) of certified "Pistacchio Verde di Bronte DOP" shelled pistachio.

Option B: in exchange for € 200.00 per plant, paid after the signing of the agreement in terms of purchase of future goods (chap. I art. 1472 of the Civil Code), the adopter will receive at home:

N°4 packs (250 g. each) of certified "Pistacchio Verde di Bronte DOP" pistachio in shell;  
N°4 packs (250 g. each) of certified "Pistacchio Verde di Bronte DOP" shelled pistachio;  
N°1 jar (190 g.) of sweet pistachio cream;  
N°1 jar (190 g.) of pistachio pesto.

Option C: in exchange for € 300.00 per plant, paid after the signing of the agreement in terms of purchase of future goods (chap. I art. 1472 of the Civil Code), the adopter will receive at home:

N°8 packs (250 g. each) of certified "Pistacchio Verde di Bronte DOP" pistachio in shell;  
N°6 packs (250 g. each) of certified "Pistacchio Verde di Bronte DOP" shelled pistachio;  
N°3 jars (190 g. each) of sweet pistachio cream;  
N°3 jars (190 g. each) of pistachio pesto.

Option D: in exchange for € 600.00 per plant, paid after the signing of the agreement in terms of purchase of future goods (chap. I art. 1472 of the Civil Code), the adopter will receive:

N°16 packs (250 g. each) of certified "Pistacchio Verde di Bronte DOP" pistachio in shell;  
N°16 packs (250 g. each) of certified "Pistacchio Verde di Bronte DOP" shelled pistachio;  
N°5 jars (190 g. each) of sweet pistachio cream;  
N°5 jars (190 g. each) of pistachio pesto.

Art. 8 - The payment method is bank transfer. The "I LOCHI" business network himself undertakes to send bank details to the adopter upon receipt of the signed agreement.

Art. 9 - For all that has not been expressly reported in this agreement, please refer to Civil Code: Fourth Book - Article 1470 and following - section 1 General Provisions - Chapter I "Sales" - Title III "Individual contracts".
